

ORDINANCE # 241

AN ORDINANCE REDISTRICTING THE WARDS FOR THE TOWN OF ASHLAND CITY, TENNESSEE.

WHEREAS, a recent census was done for the year of 2000, and

WHEREAS, the Town of Ashland City desires to change the existing voting district boundaries which were last changed in 1995 by Ordinance 125 so that they are more uniform and equal in population with no more variance than plus or minus ten percent of the population and in conformance with Baker v. Carr, 369 U.S 186 (1962) and

WHEREAS, the Town of Ashland City's charter provides under Section 4, "That the city shall be divided into three wards. Any existing Act of ordinance dividing the city into three wards shall continue in force and effect until modified or changed as herein provided and authorized. The City Council may from time to time alter, modify or change the boundaries of existing wards, or designate new boundaries thereof, by ordinance duly enacted. The number of wards shall not be increased or decreased, nor shall the boundaries be changed within sixty days preceding an election" now, therefore:

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF ASHLAND CITY, TENNESSEE THAT:

SECTION 1 Ward One boundaries shall be as follows: From Main Street at Frey Street, south along Main Street to the North boundary of Forrest Street, Thence Forrest Street in an easterly direction to the intersection of Forrest Street and Bell Street then North on Bell Street to Frey Street including all property on the easterly side of Frey Street to the corporate city limits. The Streets included in Ward 1 are Bell, Bellwood, Boyd, Brookhollow, Duke, Fairview Circle, all odd numbered residences on Forrest, Gallaher, Gloria Circle, Helen, Holloway Drive, Katye Court, Lakeview Drive, Lowe, Miller Plaza, North Poole, odd numbered addresses on South Main Street located between Frey Street and Forrest , Stratton Boulevard, Stratton Lake Road, Tucker, Turner, Van Hook Drive and Walden Woods.

SECTION 2 Ward Two boundaries shall be as follows: Starting at the corner of South Main Street and Forrest Street on the right hand side of the Road and including all even numbered addresses to the intersection of Forrest/Fairgrounds Road and Bell Street then easterly to the intersection of Forrest Street and Veterans Road and then southerly on to the intersection

of Forrest Street/Fairgrounds Road and Old Hyde's Ferry Pike and then southerly on Old Hydes Ferry Pike to Highway 12 to County line. From County line northerly on Highway 12 to intersection of Highway 12 and Cumberland Street and including all property on the west side of Main Street to the Cumberland River. The Streets included in Ward Two are: Adkisson, Allenwood Road, Ashton Lane, Bluegrass Road, Bluffview, By-Pass Road, Caldwell Road, Chestnut, Clifton, everything south side of Cumberland, East Elm, East McQuarry, Eisenhower Drive, Elizabeth, Fairgrounds Road, Gallaher Road, Graham Road, Hale, Harris, Hibiscus, Hickory Circle, Highway 12 South, Maple Drive, Marable, Marrowbone, Nashville Bridge Road, Nimitz Court, Old Hydes Ferry Road, Oliver Drive, Patton Court, Reed Drive, Rhea Street, River Trace, Riverview Lane, Robin Hood Road, Sandy Run Road, Smith, South Poole Street, Spring, Thompson Road, Veteran's Road, Walnut, West Elm, West McQuarry, Willow, Williamsburg.

SECTION 3 Ward Three boundaries shall be as follows: Starting at the North side of Cumberland Street and the natural boundary of Marks Creek and the Cumberland River easterly down Cumberland Street to Main Street and then Southerly down Main Street to intersection of Main Street and Frey Street (Highway 49) and then northeast up Frey Street to the intersection of Frey Street and Bell Street. From Bell Street southeast to City limits including Ashland Heights Subdivision back to Frey Street (Highway 49). From Frey Street (Highway 49) north with the boundary of the City limits and then southwest along the boundary of the City limits thence northwest along the boundary of the City limits to a natural boundary of the City limits and Marks Creek westerly to Highway 12 North and continuing around southerly along with Marks Creek and the boundary of the City limits to the northern side of Cumberland Street. The Streets included in Ward Three are Annette Drive, Ash Court, Ashland Court, Ashland Drive, Batson Street, Bowker Street, Brinkley Street, Cedar Court, Cedar Drive, Cumberland Street, Frey Street, Hillwood Circle, Hillwood Court, Hillwood Drive, Highway 12 North, Jefferson Street, Jupiter Court, Lenox Street East, Lenox Street West, Mars Court, Mulberry Street, Natures Trail, North Main Street, Oak Circle, Oak Street, Ruth Drive Saturn Court, Skyview Drive, Spann Drive, Split Rail Drive, Sycamore Street, Valley View Street, Vine Street, Washington Street, Water Street.

SECTION 4 Date of Effect. This Ordinance shall take effect from and after its final passage, the public welfare requiring it.
