

ORDINANCE 96

AN ORDINANCE OF THE CITY OF ASHLAND CITY, TENNESSEE, ADOPTING A BUDGET AND ESTABLISHING A PROPERTY TAX RATE FOR THE FISCAL YEAR JULY 1, 1993 THROUGH JUNE 30, 1994.

BE IT ORDAINED BY THE CITY OF ASHLAND CITY, THAT;

SECTION 1. A BUDGET CONSISTING OF THE AVAILABLE FUNDS AND APPROPRIATE LISTED IN SECTION 2 AND SECTION 3 BELOW BE ADOPTED FOR FISCAL YEAR JULY 1, 1993 THROUGH JUNE 30, 1994.

SECTION 6. THERE IS HEREBY LEVIED A PROPERTY TAX OF \$0.70 PER \$100 OF ASSESSED VALUATION FOR THE PURPOSE OF FUNDING GENERAL FUND SERVICES.
